This instruction implements AFPD 36-26, *Total Force Development*. It explains what documents and publications the Muir S. Fairchild Research Information Center (MSFRIC) receives regularly and how to answer MSFRIC requests for information. For purpose of this instruction, the terms document and publication refer to information in all formats including writings, audio and video recordings, film, electronic, pdf, and any other forms of information storage. Refer recommended changes and/or corrections to this publication to the Office of Primary Responsibility (OPR) using the AF Form 847, *Recommendation for Change of Publication*, through your chain of command. Submit waiver requests to AUL/CL, 600 Chennault Circle, Maxwell AFB AL 36112-6010. Ensure that all records created as a result of processes prescribed in this publication are maintained in accordance with Air Force Manual (AFMAN) 33-363, *Management of Records*, and disposed of in accordance with the Air Force Records Information Management System (AFRIMS) Records Disposition Schedule (RDS). This publication applies to Air University (AU) Schools and Centers, except the Barnes Center and the Holm Center. It does not apply to AF Reserve or ANG units; however, it may apply to documents written while students are attending applicable school or center. The Air Force Institute of Technology (AFIT) has its own library where all of AFIT's appropriate academic and scholarly contributions are archived and stored. The use of the name or mark of any specific manufacturer, commercial product, commodity, or service in this publication does not imply endorsement by the Air Force.

1. MSFRIC Requirements.

1.1. MSFRIC shall receive AU publications and documents regularly and automatically so its collection of documents is comprehensive enough to meet the reference and research needs of AU and the Air Force.

1.2. MSFRIC shall receive copies of all publications and documents that give information on AU programs, state or support policy decisions, or have research or reference value on the AU mission and its operations. Examples include: Business Case Analyses, self-studies for accreditation, and Professional Studies Papers. Faculty publications are excluded.

1.3. AU activities that create these publications and documents send only one copy to MSFRIC and establish procedures to ensure that MSFRIC receives all the items described in paragraph 3. The procedures will address the media format appropriate to the specific publication or document. MSFRIC prefers that items are sent electronically.

1.4. The staff, faculty, and students of AU participating in educational, doctrinal, and research programs are the primary readers of classified documents sent to MSFRIC. MSFRIC handles and stores classified information up to and including TOP SECRET, Restricted Data.

2. Responsibilities: AU activities that send documents and publications to MSFRIC are responsible for maintaining copies of documents in accordance with AFI 33-360, *Publications and Forms Management*, and other pertinent directives.

3. AU Schools and Centers: AU schools and centers will add MSFRIC to their distribution lists for:

3.1. Students' papers (Air War College, Air Command and Staff College, School of Advanced Air and Space Studies) which meet school releasability standards

3.2. Self-Studies for accreditation (SACS, PAJE)

3.3. Research reports and Business Case Analyses

4. Forwarding Information: The MSFRIC Director corresponds directly with all Air Force activities to carry out this instruction. Materials sent to the attention of (or for action by) the Commander, AU, or to a specific AU agency do not satisfy the MSFRIC need for documents and publications. Send all publications and documents to AUL/LTSA, Bldg 1405, 600 Chennault Circle, Maxwell AFB AL 36112-6010. Send classified publications and documents to AUL/ES, Attn: Security Officer. Information for the Air Force Historical Program (see AFI 84-101, *Historical Products, Services and Requirements*) is separate from MSFRIC requirements. Send that information to AFHRA/ISA, Bldg 1405, 600 Chennault Circle, Maxwell AFB AL 36112-6010.
