This instruction implements AFPD 36-1, General Civilian Personnel Provisions and Authorities, and applies to all civilian personnel assigned, attached or associated with the Eglin AFB complex. This instruction requires collecting and maintaining information protected by the Privacy Act (PA) of 1974 authorized by Title 5 U.S.C., Chapters 53, 55, 81, 10 U.S.C. 8012, E.O. 9397; system of records notice FO36 SAFAAA. Records from this system of records may be disclosed for any of the blanket routine uses published by the Air Force. The purpose is to ensure that departing employees properly turn in all materials and equipment, settle accounts and provide certification for clearance of administrative and security responsibilities. Disclosure is voluntary; however, failure to provide the information could result in delayed final clearance processing. Send recommended changes or comments for this publication to the Office of Primary Responsibility (OPR) using the AF Form 847, Recommendation for Change of Publication. Ensure that all records created as a result of processes prescribed in this publication are maintained in accordance with AFMAN 33-363, Management of Records, and disposed of in accordance with the Air Force Records Disposition Schedule (RDS) located at <https://www.my.af.mil/gcss-af61a/afrims/afrims>.
