This supplement implements AFI36-2903 and AFI36-2903\_AETCSUP. It establishes policies and procedures specific to Maxwell AFB. Refer recommended changes and/or corrections to this publication to the Office of Primary Responsibility (OPR) using the AF Form 847, *Recommendation for Change of Publication*, through your chain of command. Ensure that all records created as a result of processes prescribed in this publication are maintained in accordance with Air Force Manual (AFMAN) 33-363, *Management of Records*, and disposed of in accordance with the Air Force Records Information Management System (AFRIMS) Records Disposition Schedule (RDS). This supplement applies to all Air Force personnel (Active Duty, Guard and Reserve) assigned or attached to Maxwell AFB. Submit any waiver requests to guidance contained in this supplement to the OPR through the appropriate chain of command. The use of the name or mark of any specific manufacturer, commercial product, commodity, or service in this publication does not imply endorsement by the Air Force.

## *SUMMARY OF CHANGES*

This interim change: updates the Certifying and Approving Authorities; adds guidance on Morale Undershirts; and updates guidance on wear of earphones.

**1.2.13.** Authorized headgear will be worn while outdoors unless in an area designated as a no-hat area by the installation commander or equivalent. See Attachment 8 for designated no-hat areas.

1.2.14. **(Added)** Military members are required to be in uniform for all in- and out-processing appointments. (Reference AFI 36-2102, *Base-Level Relocation Procedures*.)

5.1.3. Military members are authorized to wear squadron-approved morale undershirts with their ABUs on Fridays (only one color per squadron). Morale undershirts are individual purchase only, not unit-funded.

6.2.7. *Black Watch Cap.* Wear authorized from 1 October – 31 March or as extended by the installation commander.

6.2.8. *Sage Green Watch Cap.* Wear authorized from 1 October – 31 March or as extended by the installation commander.

6.5.2.1. See Attachment 7 for approved unit emblems.

7.1.7.1. The wear of an optional solid black or dark blue baseball/sport cap with the Air Force symbol or “U.S. Air Force” printed/embroidered on the front during organized PT; also authorized during individual PT. If authorized, caps are to be worn outdoors only.

7.1.13. See AFI 91-207\_AETCSUP\_MAXWELLAFB SUP, *The US Air Force Traffic Safety Program*, paragraph 3.6.6. for guidance on wearing headphones and earphones.

9.6.10. **(Added)** Vest. Security Forces Base Entry Controllers are authorized to wear the yellow/blue reflective vest during inclement weather and from dusk until daylight.

10.3.27. Exercise Evaluation Team Badges (with “EET” identifier). Authorized for wear by base exercise evaluation team members during exercise periods. Team members may wear base exercise evaluation team badges and vest with the acronym “EET”.

**Attachment 8 (Added)****APPROVED NO-HAT/NO-SALUTE AREAS****A8.1. (Added)** Designated no-hat/no-salute areas.

A8.1.1. **(Added)** For safety considerations, the flight line, CATM range and skeet range are no-hat and no-salute areas.

A8.1.2. **(Added)** To facilitate mission effectiveness and efficiency, the open-air quadrangles within the confines of ACSC, SOC, AFLOA/AFJAGS, and 42 ABW headquarters building are no-hat and no-salute areas.

A8.1.3. **(Added)** The LeMay Center enclosed connector between Bldgs 1400 and 1400A and the Maxwell Clinic courtyard are authorized no-hat and no-salute areas.

A8.1.4. **(Added)** The Blue Thunder/Leadership Reaction Course (Project X, Combatives area and Cultural Leadership area) facility is a no-salute area during warrior training events—hats will be worn.

A8.1.5. **(Added)** At Gunter Annex, the patio behind Bldg 1143 is a no-hat and no-salute area.

A8.1.6. **(Added)** Bldg 205, the area to include the AFLMA picnic area, adjacent to southeast wing of Bldg 205, enclosed parking area, and door-to-door building access is a no-hat and no-salute area.

A8.1.7. **(Added)** The breezeway between Bldg 892 and Bldg 892 auditorium is a no-hat and no-salute area.

A8.1.8. **(Added)** The Leadership Reaction Course area is a no-salute area during training events—hats will be worn.

A8.1.9. **(Added)** The breezeway between Bldg 1487 and Bldg 1487A is a no-hat and no-salute area.

**A8.1.10.** Bldg 501, Education Center courtyard is a no-hat and no-salute area.

A8.1.11. **(Added)** 908 AW: The courtyard area and sidewalks transitioning between buildings 1050 and 1052. Aircrew transitioning to and loading into crew transportation adjacent to buildings 1050 and 1051.

A8.1.12. **(Added)** Maxwell Fire Station #1, Bldg. 1092, the vehicle ramp facing Maxwell Blvd. and the picnic tables/patio area on the west side facing the refueling yard.

A8.1.13. **(Added)** Maxwell Fire Station #2, Bldg.834 on Gunter Annex, the vehicle ramps facing Turner Blvd., and the backside ramp connecting to Computer Loop Road and near picnic tables and patio area.

**A8.2. (Added)** No-hat and/or no-salute areas will be visibly marked and unit commanders will brief their personnel on the designated areas with particular emphasis on the limits of such an area. Commandants and commanders seeking additional designated no-hat and/or no-salute areas may seek approval—in writing—from the installation commander.
