This instruction describes the proper completion and submission of 59 Medical Wing (MDW) Form 4001, *Wilford Hall Ambulatory Surgical Center Patient History and Breast Imaging Questionnaire*. This instruction applies to all personnel assigned, attached or under contract to the 59th Medical Wing. This instruction does not apply to the Air National Guard or Air Force Reserve. This publication requires the collection and or maintenance of information protected by the Privacy Act of 1974 authorized by 10 U.S.C. 55, *Medical and Dental Care*, and E.O. 9397 (SSN). SUMMARY OF CHANGES

This revision of 59 MDWI 44-177 updates 59 MDW Form 4001.

1. Overview. The purpose of 59 MDW Form 4001 is to document the past and present medical history of our Mammography patients.

2. Personnel Responsibilities. Patients, mammography technologists, and providers use 59 MDW Form 4001 to document pertinent medical and breast health information to use during the Mammographic examination.

3. Forms Submission. 59 MDW Form 4001 will be maintained in the patient's Mammography folder and/or scanned into the Picture Archival Communication System (PACS). If scanned into PACS, 59 MDW Form 4001 will be destroyed. PACS will keep a permanent electronic record. The form is not scanned into Armed Forces Health Longitudinal Technology Application.
