- 1. PURPOSE. As directed by DODI 5525.15 Law Enforcement (LE) Standards and Training in the DoD, Guideline 1, this AFJQS identifies the minimum training requirements to become a certified law enforcement officer and be awarded Special Experience Identifier (SEI) L3/3LE. This AFJQS must be utilized at all installations with law enforcement missions and serves as a roadmap to develop the Law Enforcement Master Training Plan (MTP) and Individual Training Plan (ITP). This AFJQS applies to military and civilian Airmen and Guardians assigned to perform duties as law enforcement Patrol, Trainers, and Program Managers/Planners and may be supplemented to capture unique requirements not common across the Total Force. This AFJQS will remain in effect until superseded or rescinded.
- 2. TASK QUALIFICATION. Personnel will be qualified to the GO/NO GO standard on this AFJQS. GO means the individual can perform the task without assistance utilizing appropriate instructions or other procedural guidance. Initial training for items in Part II marked with a single asterisk "*" in the critical column of the AFJQS must be received through in-residence training at a DoD POST accredited training program. Limited exceptions to the in-residence requirements are controlled by Air Force Security Forces Center (AFSFC) S3T and only available through distance learning. Annual and in-service training listed in Part II of this AFJQS must be taught by certified law enforcement instructors and may be delivered through on-the-job training, in-residence, distance learning (DL), or web-based courses. A task qualified supervisor/trainer/certifier from that respective functional area must document training and certification for a person to be considered trained and certified on a task. To be awarded the Special Experience Identifier of L3/3LE Airmen and Guardians must be trained and certified on all DODI 5525.15 Guideline 1 requirements identified with a single asterisk "*" in the critical task column of the AFJQS Part II. Finally, when conducting their training needs analysis, commanders should consider whether supporting response personnel require additional training the following tasks.

3. TRAINING DOCUMENTATION AND TRAINER/CERTIFIER IDENTIFICATION.

Document training required by this AFJQS in accordance with DAFI 36-2689, *Total Force Training Program*, paragraph 5.3.3.3, and any automated learning management system (LMS) procedural guides. Military and civilian personnel will with both utilize the Air Force approved LMS unless it is unavailable. In those instances, military and civilian personnel will utilize a paper copy record of this AFJQS and retain it in their On-the-Job training record for military and in the Supervisor's Employee Brief for civilian personnel. All tasks identified on this AFJQS require third party certification in order for the trainee to be considered certified. If a military or civilian trainee is assigned an additional duty or task not included in an individual's CFETP or this AFJQS, the supervisor will add the task(s) to the MTP and ITP.

- **4. ADDITIONAL DUTY or TASK.** If a law enforcement member is assigned an additional duty or task not listed in this AFJQS, the supervisor will develop an AF Form 797, *Job Qualification Standard Continuation/Command JQS*. The supervisor, trainer, or Program Manager will then develop a plan for the member to receive training and certification to become duty position qualified.
- **5. RECERTIFYING.** For tasks previously certified and required in the current duty position, supervisors/trainers/certifiers will employ the evaluate-train-evaluate process to recertify personnel on tasks. Recertification is not required unless there is a break in the AFJQS task for more than 366 consecutive calendar days. This does not negate the requirement for military and civilian members to undergo annual or otherwise required duty position evaluations, ensuring members are proficient on AFJQS tasks. If a law enforcement member has not performed LE duties for 3 or more years, they must take and pass the DoD POST Commission LEX and an inservice training program before assuming full duties as a DoD LE officer.
- **6.** This AFJQS has been coordinated with all applicable Career Field Managers (CFM) and Major Command Functional Managers (MFM). The overall POC for this AFJQS is AFSFC/S3T <u>AFSFC.S3T.Training@us.af.mil</u>.
