1	17	8.3.3	<p>Replace entirety of Task Qualification Training paragraph (8.3.3) with the following verbiage: “<i>Column 2 (Deployment */SEI +/-CBRN ~ Tasks) tasks identified with an (*) are Aircraft Maintenance Functional MCA tasks. Maintenance technicians should be qualified on all these tasks (as applicable per airframe) prior to deployment. Tasks identified with a (+) are required prior to award of the aircraft or system SEI. Currently no tasks are identified with a (+). Tasks identified with an (~) require annual CBRN (Training Task Qualification) training in the work center. Per DAFI10-2503, para 6.5.1.1., CBRN Defense TQT is defined as a hands-on event with a minimum of two (2) hours in MOPP gear performing regular duties. At a minimum, individuals will be evaluated on their ability to accomplish AFSC-specific tasks while wearing CBRN defense IPE in MOPP Four (4) for a minimum of two hours per identified task. In addition to AFSC-specific tasks, individuals must be evaluated on their ability to hydrate while wearing CBRN defense IPE in MOPP 4 at the beginning and completion of each identified task. Document training on an DAF 797 or local equivalent until myTraining has capability.</i>”</p>

The verbiage within Row 6 will state the following:</p> <p>ATTACHMENT 3</p> <p><i>NOTE 1: In addition to the career field requirement for attachment 2 compliance, the tasks and knowledge in attachment 3 will be performed by personnel assigned to maintain aircraft NOT listed in specific Aircraft CFETP Attachments here within.</i></p> <p><i>NOTE 2: All tasks and knowledge items shown with a proficiency code are trained during war time.</i></p> <p><i>NOTE 3: Users are responsible for annotating training references to identify current references pending STS revision.</i></p> <p><i>NOTE 4: Address comments and recommended changes through the MAJCOM Functional Managers to the AETC Training Manager, DSN 736-6481.</i></p> <p><i>NOTE 5: Multi generator system will replace single generator system once assets are available."</i></p>
