This Mission Directive implements guidance in Air Force Instruction (AFI) 38-101, *Manpower and Organization*. It delineates the mission, command relationships, and responsibilities of 380th Electromagnetic Warfare Squadron. This Mission Directive applies to individuals assigned to Headquarters, Air Force Reserve Command (HQ AFRC). It does not apply to Regular Air Force (RegAF), Space Force (SF), or Air National Guard (ANG) units. Ensure that all records created as a result of processes prescribed in this publication are maintained in accordance with (IAW) AFI 33-322, *Records Management and Information Governance Program*, and disposed of IAW the Air Force Records Information Management System and Records Disposition Schedule. Contact supporting records managers as required. Refer recommended changes and questions about this publication to the Office of Primary Responsibility (OPR) using Department of Air Force (DAF) Form 847, *Recommendation for Change of Publication*; route DAF Forms 847 from the field through the appropriate functional chain of command. SUMMARY OF CHANGES

This document has been substantially revised and needs to be completely reviewed. Major changes include update to the purpose, mission, and attachment and references.

1. Mission. The 380th Electromagnetic Warfare Squadron provides defensive space control (DSC) capabilities and space situational awareness to rapidly achieve flexible and versatile effects

in support of global and theater campaigns. The 380th Electromagnetic Warfare Squadron monitors satellite communication links to detect and geolocate satellite communication jammers, sources of electromagnetic interference or for other signals of interest for prosecution as targets or other higher authority action. The unit operates as a classic associate unit with the 16th Electromagnetic Warfare Squadron.

2. Command. The 380th Electromagnetic Warfare Squadron Commander.

2.1. Reports to the 710th Operations Group Commander.

2.2. Exercises administrative control over assigned personnel.

3. Responsibilities.

3.1. Execute commander's responsibilities as outlined in AFI 1-2, *Commanders Responsibilities*.

3.2. Provides oversight and execution of the 380th Electromagnetic Warfare Squadron mission.
