 - 2.1. Reports to their assigned Operations Group Commander.
 - 2.2. Exercises administrative control over assigned personnel.
- 3. Responsibilities.**
 - 3.1. Execute commander's responsibilities as outlined in AFI 1-2, *Commander's Responsibilities*.
 - 3.2. Provides oversight and execution of the Air Refueling mission.
