SUMMARY OF CHANGES

This document has been substantially revised and needs to be completely reviewed. Major changes include an updated purpose, mission and references.

1. Mission. 953rd Reserve Support Squadron provides trained citizen airman to integrate as part of the United States Transportation Command Joint Enabling Capabilities Commands to facilitate rapid establishment of Joint Force Headquarters, fulfill Global Response Force Execution and Bridge Joint Operational requirements. Also augments Joint Staff-Hampton Roads Joint Reserve Unit, Virginia, by providing experienced joint planners and operators to train and exercise Combatant Command Headquarters and Joint Task Force Headquarters.

2. Command. The 953rd Reserve Support Squadron Commander:

- 2.1. Reports to the Commander, Twenty Second Air Force.
- 2.2. Exercises administrative control over assigned forces.

3. Responsibilities.

- 3.1. Execute commander's responsibilities as outlined in AFI 1-2, *Commander's Responsibilities*.
- 3.2. Provides oversight and execution of the 953rd Reserve Support Squadron mission.
