**SUMMARY OF CHANGES**

**2. Command.** The Network Operations Squadron Commanders:

2.1. Reports to the 960th Cyber Operations Group Commander or the 860th Cyber Operations Group Commander.

2.2. Exercises administrative control over assigned personnel.

**3. Responsibilities.**

3.1. Execute commander's responsibilities as outlined in AFI 1-2, *Commander's Responsibilities*.

3.2. Provides oversight and execution of the network operations mission.
