This mission directive (MD) implements policy and guidance in Air Force Policy Directive (AFPD) 38-6, *Mission Directives*. It delineates the mission, command relationships, and responsibilities of 610th Air Operations Group (610 AOG). It does not apply to Regular Air Force (RegAF) or Air National Guard (ANG) units. Ensure that all records created as a result of processes prescribed in this publication are maintained IAW AFMAN 33-363, *Management of Records*, and disposed of IAW the Air Force Records Information Management System (AFRIMS) Records Disposition Schedule (RDS). Contact supporting records managers as required. Refer recommended changes and questions about this publication to the Office of Primary Responsibility (OPR) using Air Force Form 847, *Recommendation for Change of Publication*; route AF Forms 847 from the field through the appropriate functional chain of command. This publication may be supplemented at any level, but all direct supplements must be routed to the OPR of this publication prior to certification and approval. The authorities to waive wing/unit level requirements in this publication are identified with a Tier ("T-0, T-1, T-2, T-3") number following the compliance statement. See AFI 33-360, *Publications and Forms Management*, for a description of the authorities associated with the Tier numbers. Submit requests for waivers through the chain of command to the appropriate Tier waiver approval authority, or alternately, to the Publication OPR for non-tiered compliance items.

1. Mission. The 610 AOG provides a single command and control (C2) structure for of geographically separated AFRC Combat Operations Squadrons (COS) and Air Component Operations Squadrons (ACOS). The 610 AOG provides administrative support, and oversight of AFRC COS and ACOS. Ensures assigned units are trained, manned and equipped to maintain

readiness for integration with the Active Component C-NAF and AFFOR with experienced mission-ready Citizen Airmen. (T-2)

2. Command. The 610th Air Operations Group Commander (CC):

- 2.1. Reports to the Commander of the Tenth Air Force. (T-2)
- 2.2. Exercises administrative control over assigned personnel. (T-2)

3. Responsibilities.

- 3.1. Execute commander's responsibilities as outlined in AFI 1-2, *Commanders Responsibilities*. (T-2)
- 3.2. Provide administrative support and training oversight of the AFRC COS and ACOS missions. (T-2)
