**(ELLSWORTHAFB) Air Force Instruction 32-6000, Housing Management, is supplemented as follows:** To identify Ellsworth Air Force Base (EAFB) positions requiring priority on-base housing. This list identifies positions where off-base residency would adversely impact installation readiness, safety, and security, or health and welfare of the base population. Key and Essential (K&E) personnel will be assigned housing on base unless otherwise excused by the 28th Bomb Wing Commander (28 BW/CC). Personnel assigned to a K&E position are required to vacate their assigned on-base home no later than one-week prior to their Wing final out-processing appointment/date in order to facilitate a smooth transition for both inbound and outbound K&E personnel. Ensure that all records created as a result of processes prescribed in this publication are maintained in accordance with (IAW) Air Force Manual 33-363, *Management of Records*, and disposed of IAW Air Force Records Information Management System (AFRIMS) Records Disposition Schedule (RDS) located at <https://www.my.af.mil/gcss-af61a/afirms/afirms/>. **SUMMARY OF CHANGES**
