This instruction implements Air Force Policy Directive (AFPD) 34-1, Air Force Services, and it establishes the 673d Air Base Wing's (673ABW) list of installation meetings as a Joint Base Elmendorf-Richardson (JBER) best practice, and provides an overview of these meetings, designates roles and responsibilities, desired outcomes and information accessibility. publication applies to all JBER community members and mission partners. It also applies to the Air National Guard and Air Force Reserve units and members. This instruction does not apply to the Civil Air Patrol. Submit requests for waivers through the chain of command to the publication OPR for non-tiered compliance items and this instruction cannot be supplemented or further extended. Refer recommended changes and questions about this publication to the office of primary responsibility (OPR), using AF Form 847, Recommendation for Change of Publication. Route the AF Forms 847 through the appropriate chain of command. Ensure all records created as a result of processes prescribed in this publication are maintained in accordance with Air Force Manual (AFMAN) 33-363, Management of Records, and disposed of in accordance with Air Force Records Information Management System (AFRIMS) Records Disposition Schedule (RDS). - **1. Purpose.** Provide key mission partners across the installation an opportunity to provide and receive base-wide information impacting our Service Members, civilians, and family members.
- **2. Outcome.** The dissemination of information regarding installation support, programs, initiatives and community activities to senior leadership, key spouse organizations, Family Readiness Groups and the military community at large as appropriate per meeting outcome.
