SUMMARY OF CHANGES

This document has been substantially revised and must be completely reviewed. Major changes include the addition, clarification and deletion of several delegations of authority/assignments of responsibilities within **Attachment 1**. Further details on the specific responsibilities of the Office of the Inspector General of the Department of the Air Force (SAF/IG) are provided within the subparagraphs of **Section 3**, **Responsibilities**.

1. Mission. The Inspector General of the Department of the Air Force (TIG) is authorized and established pursuant to Title 10, United States Code (USC) § 9020. The Secretary of the Air Force, pursuant to 10 United States Code (USC) §§ 9013-9016, may establish offices and officials within the Secretariat to assist the Secretary in carrying out their responsibilities. As documented by Paragraph 4.1.4 of HAFMD 1, *Headquarters Air Force*, and this Headquarters Air Force Mission Directive (HAFMD), the Office of the Inspector General of the Department of the Air Force (SAF/IG) is established as part of the Secretariat. SAF/IG independently assesses and reports on the overall readiness, economy, efficiency, and discipline of the Department of the Air Force to the Secretary of the Air Force through specified inquiries, investigations and inspections. SAF/IG ensures effective inspection and investigative systems, which includes administrative guidance and oversight for the military criminal investigative organization (MCIO) mission conducted by the Air Force Office of Special Investigations (AFOSI). SAF/IG provides administrative oversight for those mission areas specified to the Department of Defense (DoD) Cyber Crime Center (DC3) outlined in Department of Defense Directive (DoDD)

- 5505.13E, *DoD Executive Agent (EA) for the DoD Cyber Crime Center (DC3)*, as delegated in **Attachment 1**. The Secretary of the Air Force retains ultimate responsibility for all policies related to the Department of the Air Force. Within their areas of responsibility, SAF/IG prepares policies for approval and issues official guidance/procedures via official Air Force publications to ensure implementation of those policies.
- **2. Organizational Relationships.** The Secretary of the Air Force is responsible for, and has all legal authority necessary to conduct, the affairs of the Department of the Air Force. The Secretariat, Chief of Staff of the Air Force, the Air Staff, Chief of Space Operations, and the Space Staff perform their Department of the Air Force functions subject to the authority, direction, and control of the Secretary of the Air Force.
 - 2.1. **TIG** reports to the Secretary of the Air Force, serves as an agent of the Secretary within assigned policy and program domains, and provides guidance, direction, and oversight for all matters pertaining to the formulation, review, and execution of plans, policies, programs, and budgets within their area of responsibility. TIG is accountable to the Secretary for results achieved within the policy and program domains assigned by this Directive.
 - 2.2. **TIG and SAF/IG** work in cooperation with the Air Force General Counsel, The Judge Advocate General, and the Auditor General, and their respective offices, as well as other HAF organizations, which are responsible, pursuant to Chapters 903 and 905 of Title 10 (10 USC §§ 9013-9023 and §§ 9031-9038), for assisting the Secretary of the Air Force in carrying out their responsibilities.
 - 2.3. **SAF/IG** has responsibility for administrative guidance and oversight of three field operating agencies: The Air Force Inspection Agency (AFIA), whose mission is documented in Headquarters Air Force Mission Directive (HAFMD) 31; the AFOSI, whose mission is documented in HAFMD 39; and the DC3, whose mission will be documented in a future Department of the Air Force (DAF) Mission Directive.
- **3. Responsibilities. TIG** is specifically responsible for:
 - 3.1. Inquiry into and reporting upon the discipline, efficiency, economy, and readiness of the Air Force through:
 - 3.1.1. The Air Force Inspection System (AFIS).
 - 3.1.2. The Complaints Resolution Program.
 - 3.1.3. Portions of the Insider Threat Program in collaboration with the Administrative Assistant to the Secretary of the Air Force (SAF/AA).
 - 3.1.4. Administrative oversight of AFOSI's criminal and counterintelligence programs.
 - 3.2. Performing other duties prescribed by the Secretary of the Air Force, the Chief of Staff of the Air Force, or the Chief of Space Operations. Such other duties include, but are not limited to:
 - 3.2.1. Serve on the Defense Council on Integrity and Efficiency (DCIE).
 - 3.2.2. Serve on the Air Force Council (AFC).
 - 3.2.3. Serve as advisor to the USAF Academy Executive Steering Group (ESG).
 - 3.2.4. Serve on the Sexual Assault and Prevention and Response ESG.

- 3.2.5. Serve on the Air and Space Expeditionary Force Forum.
- 3.2.6. Serve on the Air Force Lessons Learned General Officer Steering Group.
- 3.2.7. Serve on the Information Technology Management Board (ITMB).
- 3.2.8. Serve on the Nuclear Oversight Board (NOB).
- 3.3. Proposing programs of inspection and investigation to the Secretary of the Air Force.
- 3.4. Cooperating fully with the Inspector General of the Department of Defense in connection with the performance of any duty or function by the Inspector General of the Department of Defense under the Inspector General Act of 1978 (5 USC App. § 3) regarding the Department of the Air Force.
- 3.5. Acting as the functional and force management proponent for the Air Force Inspector General system.
- 3.6. Communicating directly with the Secretary of the Air Force, Chief of Staff of the Air Force, Chief of Space Operations, and all other Department of the Air Force command elements on IG matters, thereby providing advocacy on behalf of all Department of the Air Force commanders.
- 3.7. Supervising, directing, and guiding the AFIA.
- 3.8. Providing administrative guidance and oversight to the AFOSI.
- 3.9. Providing administrative guidance and oversight to the DC3.
- **4. Delegations of Authority/Assignment of Responsibility: Attachment 1** lists delegated authorities and assigned responsibilities to TIG / SAF/IG, Department of the Air Force. The authorities delegated and responsibilities assigned to TIG / SAF/IG, Department of the Air Force by this HAF Mission Directive may generally be re-delegated and re-assigned unless redelegation or re-assignment is expressly prohibited by the attached delegation/reassignment or superseding law, regulation, or DoD issuance. While TIG may re-delegate authorities and reassign responsibilities to other Department of Air Force officials, they will ultimately be responsible to the Secretary of the Air Force for all matters listed in **paragraph 2** of this publication. Any re-delegation of authority/re-assignment of responsibility made shall not be effective unless it is in writing. Any person re-delegating authority or reassigning responsibility in accordance with this HAF Mission Directive may further restrict or condition the authority/responsibility being re-delegated/re-assigned.
- **5. Notifications to Congress:** No re-delegation of authority/re-assignment of responsibility under this HAF Mission Directive below the level of a Deputy Assistant Secretary or three-letter office shall include authority to provide notifications or reports to Congress.

6. Continuation of Prior Re-Delegations of Authority/Assignments of Responsibility: Redelegations of authority/assignments of responsibility made prior to the date of issuance of this HAF Mission Directive remain effective insofar as such re-delegations are consistent with the terms of this HAF Mission Directive unless superseded by a new re-delegation or assignment of responsibility.

ATTACHMENT 1

DELEGATIONS OF SECRETARY OF THE AIR FORCE AUTHORITY/ASSIGNMENTS OF RESPONSIBILITY TO THE INSPECTOR GENERAL OF THE DEPARTMENT OF THE AIR FORCE

- **A1.1.** Authority relating to the protection of high risk personnel as delegated to the Secretary of the Air Force pursuant to Department of Defense Instruction (DoDI) O-2000.22, *Designation and Physical Protection of DoD High Risk Personnel*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to the AFOSI/CC.
- **A1.2.** Authority relating to suspicious activities reporting as delegated to the Secretary of the Air Force pursuant to DoDI 2000.26, *DoD Use of the Federal Bureau of Investigation (FBI) eGuardian System*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.3.** Authority relating to counterintelligence training as delegated to the Secretary of the Air Force pursuant to DoDI 3305.11, *DoD Counterintelligence (CI) Training and Certification*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.4.** Authority relating to the support of the Inspector General of the Department of Defense as delegated to the Secretary of the Air Force pursuant to Department of Defense Directive (DoDD) 5106.01, *Inspector General of the Department of Defense (IG DoD)*.
- **A1.5.** Authority relating to the support of combatant command inspectors general as delegated to the Secretary of the Air Force pursuant to DoDD 5106.04, *Defense Inspectors General*.
- **A1.6.** Authority relating to the gathering of information concerning non-DoD affiliates as delegated to the Secretary of the Air Force pursuant to DoDD 5200.27, *Acquisition of Information Concerning Persons and Organizations not Affiliated with the Department of Defense*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.7.** Authority, to include that delegated to them in their capacity as the DoD Executive Agent (EA) for Digital and Multimedia (D/MM) Forensics, relating to the DoD Forensic Enterprise for D/MM Forensics for those forensics disciplines associated with computer and electronic device forensics, audio forensics, image analysis, and video analysis as delegated to the Secretary of the Air Force pursuant to DoDD 5205.15E, *DoD Forensic Enterprise (DFE)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to the Executive Director DC3.
- **A1.8.** Authority relating to the polygraph program as delegated to the Secretary of the Air Force pursuant to DoDD 5210.48, *Credibility Assessment (CA) Program*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.9.** Authority relating to Polygraph and Credibility Assessment procedures as delegated to the Secretary of the Air Force pursuant to DoDI 5210.91, *Polygraph and Credibility Assessment*

- (*PCA*) *Procedures*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.10.** Authority relating to efforts to detect, identify, exploit, penetrate, degrade, and counter or neutralize espionage, intelligence collection, sabotage, sedition, subversion, assassination, and terrorist activities conducted for or on behalf of foreign powers, organizations, persons, or their agents directed against U.S. national security interests or DoD and it personnel, information, materiel, facilities, and activities as delegated to the Secretary of Defense pursuant to DoDD O-5240.02, *Counterintelligence (CI)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.11.** Authority relating to conducting, managing, coordinating, controlling, and reporting requirements for counterintelligence investigations and criminal violations as delegated to the Secretary of the Air Force pursuant to DoDI 5240.04, *Counterintelligence (CI) Investigations*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.12.** Authority relating to technical surveillance countermeasures services as delegated to the Secretary of the Air Force pursuant to DoDI 5240.05, *Technical Surveillance Countermeasures (TSCM)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.13.** Authority relating to the Counterintelligence Awareness and Briefing Program as delegated to the Secretary of the Air Force pursuant to DoDD 5240.06, *Counterintelligence Awareness and Reporting (CIAR)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.14.** Authority relating to the classification of counterintelligence information as delegated to the Secretary of the Air Force pursuant to DoDI C-5240.08, *Counterintelligence (CI) Security Classification Guide (U)*, a DoDI classified as Confidential, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.15.** Authority relating to the counterespionage program as delegated to the Secretary of the Air Force pursuant to DoDI S-5240.09, *Offensive Counterintelligence Operations (OFCO) (U)*, a DoDI classified as Secret, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.16.** Authority relating to counterintelligence requirements as delegated to the Secretary of the Air Force pursuant to DoDI O-5240.10, *Counterintelligence (CI) in the DoD Components*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.17.** Authority relating to the establishment, development, maintenance, and oversight of counterintelligence functional services (CFS) as delegated to the Under Secretary of Defense for Intelligence pursuant to DODI 5240.16, *Counterintelligence Functional Services (CIFS)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.

- **A1.18.** Authority relating to counterintelligence collection reporting as delegated to the Secretary of the Air Force pursuant to DoDI S-5240.17, *Counterintelligence Collection Activities* (*CCA*) (U), a DoDI classified as secret, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.19.** Authority relating to counterintelligence analysis and production as delegated to the Secretary of the Air Force pursuant to DoDI 5240.18, *Counterintelligence (CI) Analysis and Production*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.20.** Authority relating to counterintelligence activities as delegated to the Secretary of the Air Force pursuant to DoDI 5240.19, *Counterintelligence Support to the Defense Critical Infrastructure Program*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.21.** Authority relating to counterintelligence inquiries as delegated to the Secretary of the Air Force pursuant to DoDI O-5240.21, *Counterintelligence (CI) Inquiries*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.22.** Authority relating to conducting and managing counterintelligence support to force protection as delegated to the Secretary of the Air Force pursuant to DoDI 5240.22, *Counterintelligence Support to Force Protection*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.23.** Authority relating to counterintelligence activities in cyberspace as delegated to the Secretary of the Air Force pursuant to DoDI S-5240.23, *Counterintelligence (CI) Activities in Cyberspace (U)*, a DoDI classified as Secret, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.24.** Authority relating to counterintelligence as delegated to the Secretary of the Air Force pursuant to DoDI O-5240.24, *Counterintelligence (CI) Activities Supporting Research, Development, and Acquisition (RDA)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.25.** Authority relating to counterintelligence activities as delegated to the Secretary of the Air Force pursuant to DoDI 5240.26, *Countering Espionage, International Terrorism, and the Counterintelligence (CI) Insider Threat*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.26.** Under the authority, direction, and control of the Director, Defense Intelligence Agency (DIA), the Joint Counterintelligence Training Academy (JCITA), pursuant to DoDI 5240.27, *Joint Counterintelligence Training Academy (JCITA)*, serves as the primary professional training and education center for advanced and joint CI training within DoD and is known as the DoD Center of Excellence for CI training.


- **A1.27.** Authority relating to seeking information from financial institutions by AFOSI as delegated to the Secretary of the Air Force pursuant to DoDI 5400.15, *Guidance on Obtaining Information from Financial Institutions*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.28.** Authority relating to criminal investigations of fraud offenses as delegated to the Secretary of the Air Force pursuant to DoDI 5505.02, *Criminal Investigations of Fraud Offenses*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.29.** Authority relating to military criminal investigations as delegated to the Secretary of the Air Force pursuant to DoDI 5505.03, *Initiation of Investigations by Defense Criminal Investigative Organizations*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.30.** Authority relating to reporting and investigating allegations of misconduct against senior officials and referring allegations of criminal misconduct against senior officials as delegated to the Secretary of the Air Force pursuant to DoDD 5505.06, *Investigations of Allegations Against Senior DoD Officials*.
- **A1.31.** Authority relating to titling and indexing subjects of criminal investigations by AFOSI as delegated to the Secretary of the Air Force pursuant to DoDI 5505.07, *Titling and Indexing in Criminal Investigations*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.32.** Authority relating to criminal investigations into certain types of sexual misconduct as delegated to the Secretary of the Air Force pursuant to DoDI 5505.08, *Military Criminal Investigative Organizations (MCIO) and Other DoD Law Enforcement Organizations Investigations of Adult, Private, Consensual Sexual Misconduct*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.33.** Authority relating to the interception of communications for law enforcement as delegated to the Secretary of the Air Force pursuant to DoDI O-5505.09, *Interception of Wire, Electronic, and Oral Communications for Law Enforcement,* but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.34.** Authority relating to investigating noncombat deaths of members as delegated to the Secretary of the Air Force pursuant to DoDI 5505.10, *Criminal Investigations of Noncombat Deaths*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.35.** Authority relating to reporting AFOSI offender criminal history data as delegated to the Secretary of the Air Force pursuant to DoDI 5505.11, *Fingerprint Reporting Requirements*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.

- **A1.36.** Authority relating to the functions of the Department of Defense Cyber Crime Center as delegated to the Secretary of the Air Force pursuant to DoDD 5505.13E, *DoD Executive Agent (EA) for the DoD Cyber Crime Center (DC3)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated to the Executive Director DC3.
- **A1.37.** Authority relating to deoxyribonucleic acid collection requirements for criminal investigations as delegated to the Secretary of the Air Force pursuant to DoDI 5505.14, Deoxyribonucleic Acid (DNA) Collection Requirements for Criminal Investigations, Law Enforcement, Corrections, and Commanders, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.38.** Authority relating to contractor disclosures of violations as delegated to the Secretary of the Air Force pursuant to DoDI 5505.15, *DoD Contractor Disclosure Program*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.39.** Authority relating to prescribing procedures for AFOSI criminal investigations by personnel not assigned to defense criminal investigative organizations as delegated to the Secretary of the Air Force pursuant to DoDI 5505.16, *Investigations by DoD Components*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.40.** Authority relating to investigating sexual assault allegations as delegated to the Secretary of the Air Force pursuant to DoDI 5505.18, *Investigation of Adult Sexual Assault in the Department of Defense*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.41.** Authority relating to establishing a special victim capability as delegated to the Secretary of the Air Force pursuant to DoDI 5505.19, *Establishment of Special Victim Investigation and Prosecution (SVIP) Capability within the Military Criminal Investigative Organizations (MCIOs), but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.*
- **A1.42.** Authority relating to AFOSI's implementation of the Law Enforcement Officers Safety Act as delegated to the Secretary of the Air Force pursuant to DoDI 5525.12, *Implementation of the Amended Law Enforcement Officers Safety Act of 2004 (LEOSA)*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.43.** Authority relating to establishing procedures for criminal investigative elements as delegated to the Secretary of the Air Force pursuant to DoDI 5525.07, *Implementation of the Memorandum of Understanding (MOU) Between the Departments of Justice (DoJ) and Defense Relating to the Investigation and Prosecution of Certain Crimes*, but limited to administrative oversight of such duties, for which independent execution authority is delegated directly from the Secretary of the Air Force to AFOSI/CC.
- **A1.44.** Authority relating to the defense hotline program as delegated to the Secretary of the Air Force pursuant to DoDI 7050.01, *DoD Hotline Program*.

- **A1.45.** Authority relating to military whistleblower protection as delegated to the Secretary of the Air Force pursuant to DoDD 7050.06, *Military Whistleblower Protection*.
- **A1.46.** Authority relating to the semi-annual report to Congress as delegated to the Secretary of the Air Force pursuant to DoDI 7750.06, *Information Requirements for Semiannual Report to the Congress*.

ATTACHMENT 2

THE OFFICE OF THE INSPECTOR GENERAL OF THE DEPARTMENT OF THE AIR FORCE (SAF/IG)



Dotted line represents SAF/IG's responsibility for administrative guidance and oversight of AFOSI, AFIA and DC3.

- **A2.1.** The Office of the Inspector General of the Department of the Air Force (SAF/IG). SAF/IG conducts inquiries into, inspects, and reports on the state of readiness, economy, efficiency, and discipline of the Department of the Air Force.
 - A2.1.1. Provides administrative guidance and oversight to Air Force Office of Special Investigations (AFOSI) while AFOSI retains its independent authority to conduct its investigative and operational mission.
 - A2.1.2. Provides administrative guidance and oversight to DC3 while DC3 retains its independent authority to conducts its mission areas.
 - A2.1.3. Guides the inspection of Department of the Air Force activities, personnel, and policies through AFIA.

A2.2. Subordinate staff offices include:

- A2.2.1. **Executive Services** (SAF/IGE). SAF/IGE supports TIG in interpreting and implementing administrative policy and managing the security and travel programs for the SAF/IG staff.
- A2.2.2. Analytics and Assessment Directorate (SAF/IGA). The Analytics and Assessment Directorate develops and executes a "system of systems" that provides TIG with trends data providing a holistic picture as to the state of discipline in the Department of the Air Force as required by Title 10 USC § 9020. This effort will keep senior leaders apprised of potential problem areas earlier, allowing commanders the opportunity to resolve issues faster, to enhance mission readiness as well as the economy and efficiency of the force.

- A2.2.3. **Complaints Resolution Directorate (SAF/IGQ).** The Complaints Resolution Directorate supports TIG as the focal point for Department of the Air Force administrative investigations and complaints resolution.
- A2.2.4. **Air Reserve Component (ARC) Advisors (SAF/IGR).** As provided in Title 10 USC § 10211, the Air Force Reserve and ANG Advisors' manpower authorizations include specific positions for ARC affairs to advise directors of higher staff levels and take part in preparing and managing policies, plans, programs, and regulations affecting the ARC.
- A2.2.5. Senior Official Inquiries Directorate (SAF/IGS). The Senior Official Inquiries Directorate supports the SAF/IG in developing policy on and conducting inquiries of complaints and allegations made against senior Department of the Air Force officials (active, reserve, ANG, civilians, and retired) in the grade of O-7 select and above; Air National Guard colonels with a certificate of eligibility; current and former members of the Senior Executive Service (SES) or equivalent; Department of the Air Force civilian presidential appointees; and other matters as directed by the Secretary of the Air Force, Chief of Staff of the Air Force, Chief of Space Operations, or TIG.
- A2.2.6. **Special Investigations Directorate** (**SAF/IGX**). The Special Investigations Directorate supports the Air Force Security and Investigative Activities Programs (S&IA), the Counterintelligence (CI) Program, the General Defense Intelligence Program (GDIP), the Military Intelligence Program (MIP), portions of the Force Protection Antiterrorism Program, and the Digital and Multimedia (D/MM) Forensics and Cyber Investigative Training Programs. SAF/IGX also manages and conducts inspections of HAF/SAF Special Access Programs (SAPs) for SAF/IG.
