AFI 34-219, dated 17 October 2007 is supplemented as follows. This supplement implements and extends the guidance of AFI 34-219, *Alcoholic Beverages Program*. The AFI is published word-for-word without editorial review. This supplement describes 30th Space Wing (30 SW) procedures for use in conjunction with the basic AFI. It applies to all personnel who sell, serve, purchase, and consume alcohol on Vandenberg Air Force Base. Maintain and dispose of records created as a result of the processes described in this instruction in accordance with Air Force Manual (AFMAN) 33-363, *Management of Records*, and AFRIMS Records Disposition Schedule (RDS) located at <https://www.my.af.mil/gcss-af61/afrims/afrims/rims.cfm>.

SUMMARY OF CHANGES

2.1.6. In addition to those areas listed in the basic instruction and this supplement, alcoholic beverages may also be served, possessed and consumed in the following areas:

Base Picnic Areas: Private parties or groups may serve and consume beer in these areas. The beer may not be sold under any circumstances.

Family living quarters:

Dormitories, including bachelor quarters (officer and NCO), transient and temporary lodging facilities, per paragraph 1.1.2 of this supplement.

2.1.8. Alcoholic beverages may be sold for on premise consumption in the following locations by Services' and AAFES' employees:

2.1.8.1. Pacific Coast Club

2.1.8.2. Rod and Gun Club

2.1.8.3. Golf Course Snack Bar

2.1.8.4. Bowling Center

2.1.8.5. Intramural Athletic Fields (beer only)

2.1.8.6. Other FSS operated snack bars and refreshment stands operated by FSS employees; e.g., Open House/Air Shows, American Heritage Week, fund raising events and approved special events.

2.1.8.7. Robin Hood (AAFES) (beer and wine coolers).

2.5.1. The Pacific Coast Club allows patrons to bring unopened bottles of wine for their personal use during private functions/catered events. The Pacific Coast Club charges a corkage fee of \$8 per bottle (industry average) for this accommodation/service. This service is not available in lounge/bar activities at the Pacific Coast Club but only events held in our Ballrooms, Warrior Rooms and Dining Room areas.
